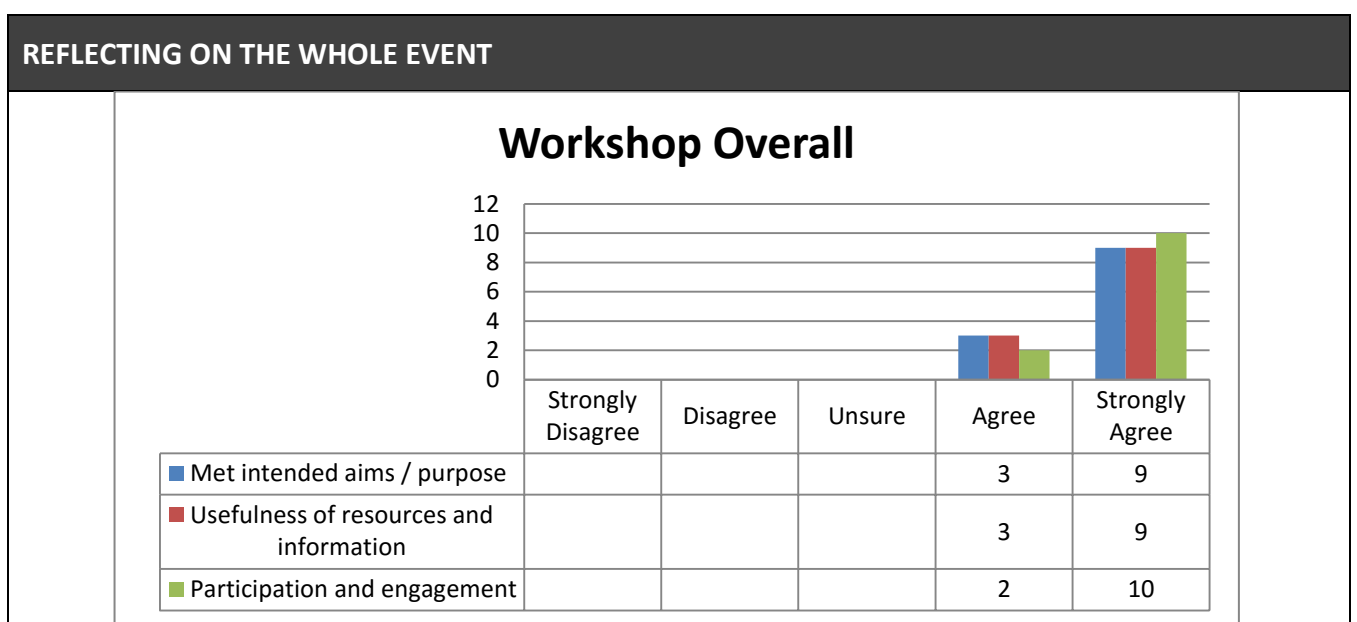
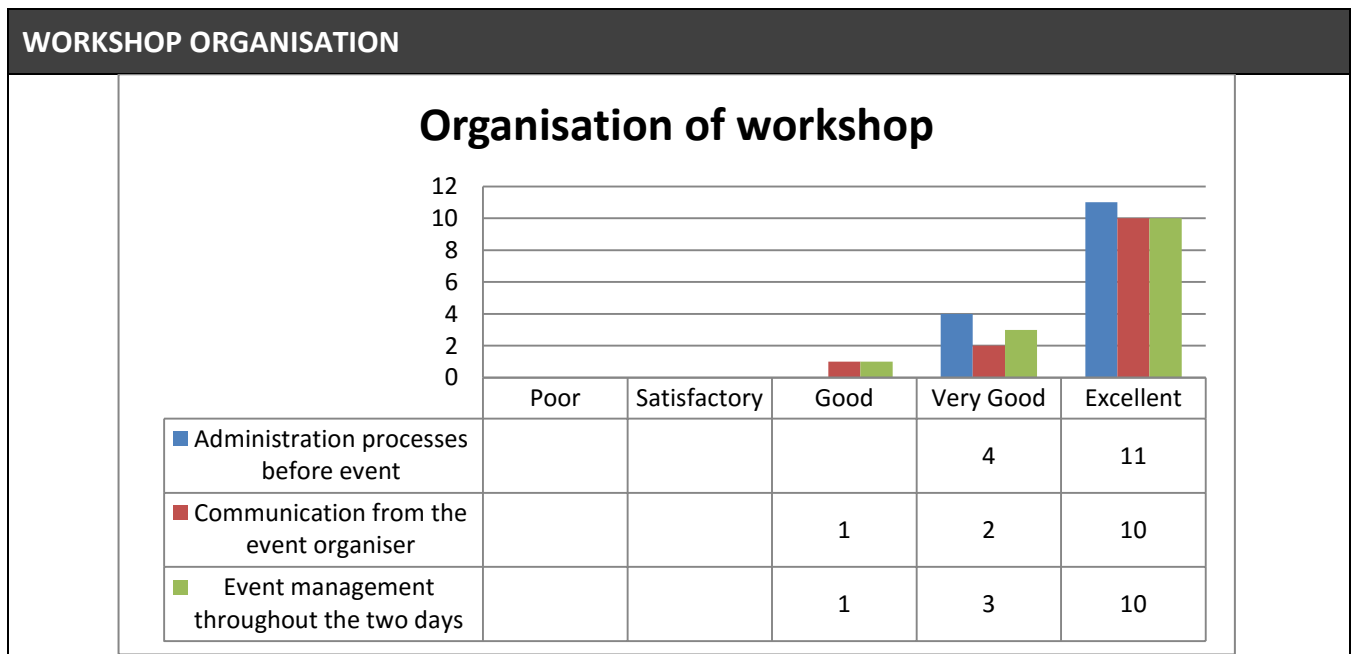


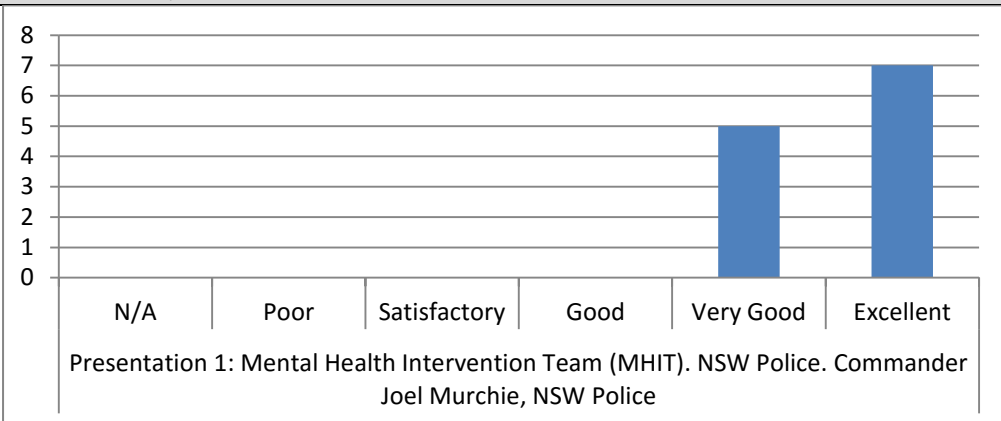

Presentation 1: Mental Health Intervention Team (MHIT). NSW Police.

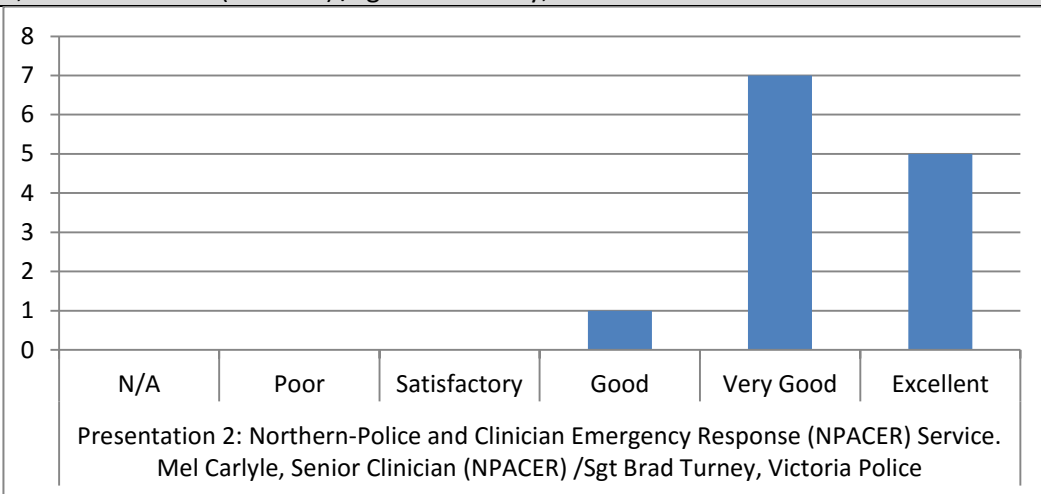

- Supported by management and structures in place for dedicated team and great training format

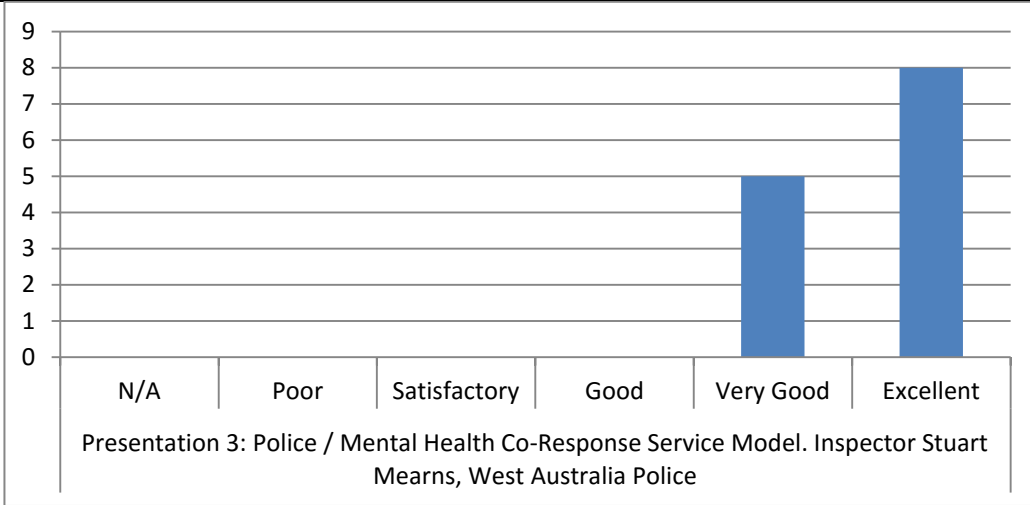
Presentation 2: Northern-Police and Clinician Emergency Response (NPACER) Service.

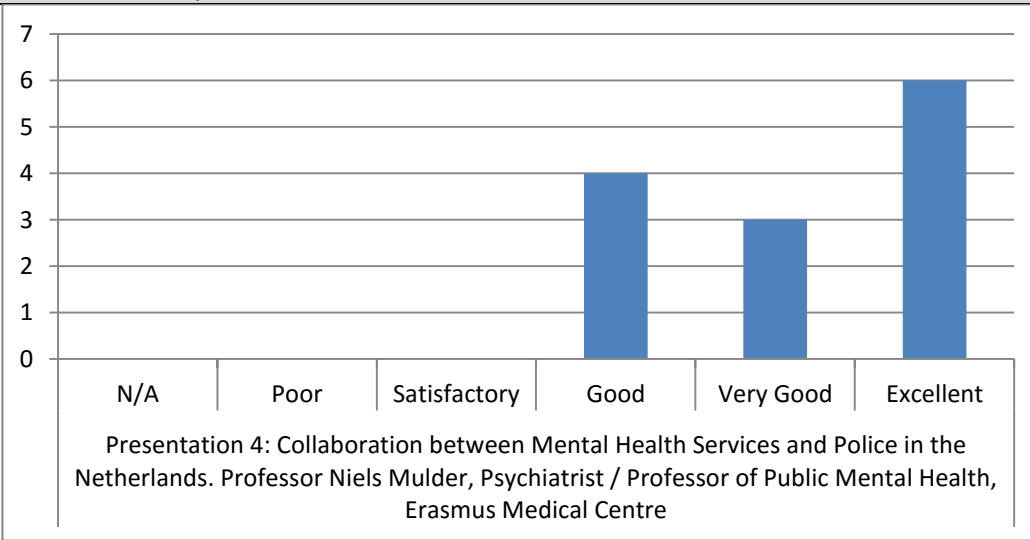
- Good presentation and value adding by presenters to some of the challenges and things that worked well.

 Inspector Stuart Mearns, West Australia Police



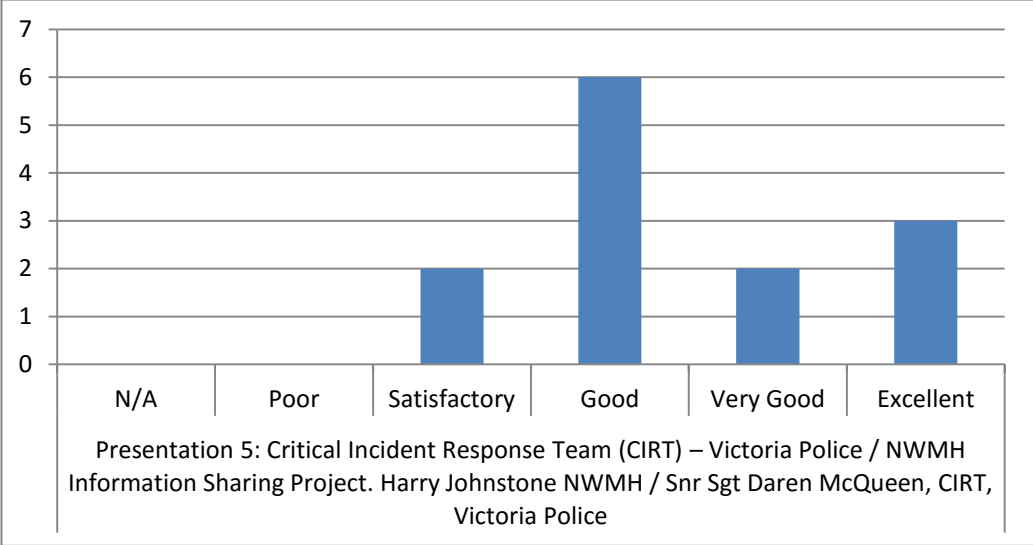
- Good value in terms of additional options from other jurisdictions.

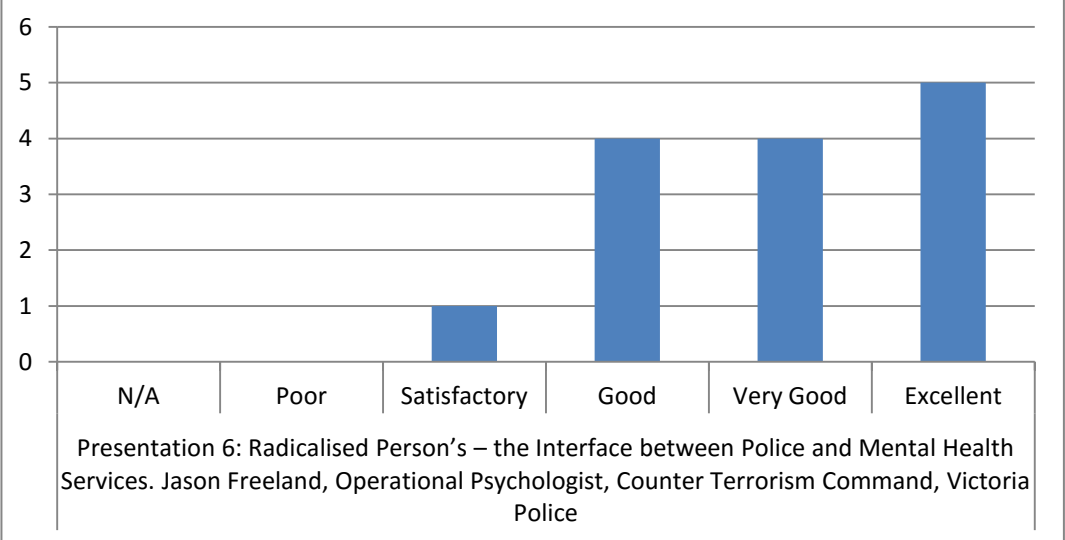
- Niels presentation gave the similarities of issues mirrored half way around the world

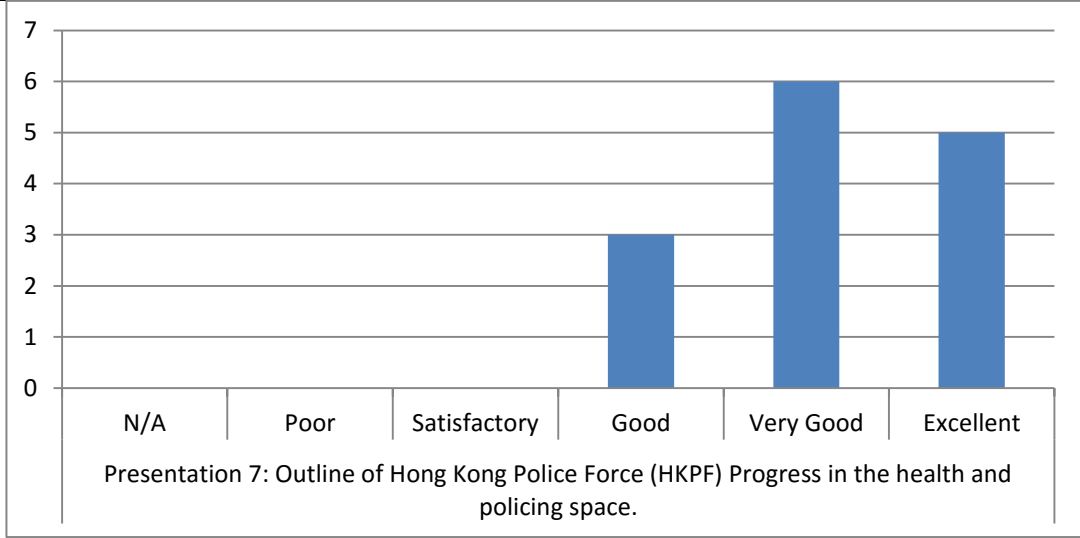
- Another option to consider in the ongoing liaison space between police & MH
